#### **GENERAL PRODUCT INFORMATION:**

ACI-0101 Spirulina Powder ET-F is manufactured <u>using raw materials of non-GMO plant origin</u>, but not from animal origin, wheat or other grains; therefore it is considered to be Bovine Spongiform Encephalopathy (BSE), Genetically Modified Organisms (GMO) and gluten free. Also, the product does not contain any Palm Oil, preservatives, pesticides or any of the 26 allergens listed in the EU Regulation No 1223/2009 as intentional ingredients. ACI-0101 Spirulina Powder ET-F does not use any solvents (Class 1, Class 2, Class 3, or Class 4) as defined by USP <467> during its manufacture. It also does not contain any known or intentional amounts of Aflatoxin / Dioxin, phthalates or any of the other materials listed below. However, this product has not been analyzed by Sun Chemical for these substances and no actual data is available.
